


Background on the Stakeholder Advisory Committee Assurance Program

APRIL's independent Stakeholder Advisory Committee (SAC) provides oversight and recommendations to APRIL on the implementation of its Sustainable Forest Management Policy (SFMP 2.0)

The SAC engages KPMG PRI to provide an independent report on progress against key SFMP 2.0 commitments

Findings on the implementation and effectiveness of SFMP 2.0 are reported to the SAC annually and support the SAC's understanding of progress and areas for improvement and help them frame recommendations for further improvement and respond to stakeholder questions and concerns.

Key performance indicators were developed in 2015-16 to support progress reporting and these have been modified and improved through stakeholder consultation in 2017 and 2018.

The indicators focus on critical SFMP 2.0 commitments.


Performance in relation to the indicators will be reported in July 2020.



Selection of field inspection sites


The draft list of concessions and estates was selected based on the following criteria:

- Supplier status (ongoing supply of fiber).
- Volume supplied (preference for suppliers > 150,000 tonnes).
- If and how recently visited by KPMG.
- Land cover change identified from independent satellite data (particularly larger areas).
- Significant increase in land claims.
- Significant decrease in land claims.
- Encroachment and loss of conservation area.
- Public sanctions by government.
- Media coverage.
- Soil type (peat or mineral).


Location of RAPP Estates and Proposed Field Sample


